**IN EXERCISE** of the powers conferred by section 3 of the Supply Act, Chapter 165, the Governor-General makes the following Regulations –

**IMPORT AND EXPORT (CONTROL) (AMENDMENT) REGULATIONS, 2022**

1. (1) These Regulations may be cited as the Import and Export (Control) (Amendment) Regulations, 2022. **Citation and commencement**

(2) These Regulations come into force on the 1st day of January, 2023.

2. The Import and Export (Control) Regulations is amended in the manner set out in the Schedule. **Amendment of Import and Export (Control) Regulations Cap. 165**
