Decision Of Haikou Municipal People's Government On The Modification Of The Measures For The Prevention And Control Of Disposable Plastic Products In Haikou City

(On March 10, 2004, the 府21st executive meeting of the Civil Administration of the Municipality of Haikou deliberated and passed the 44th of the People's Government Order of Haikou City March 18, 2004 the day of the publication of the publication of the 44th of the People's Government of Haikou, March 18, 2004)

The municipal government decided to make the following changes to the Measures for the Prevention and Control of disposable plastic products in Haikou City:

One, delete the fourth article, and the subsequent provisions will be extended in turn.

II, delete the second paragraph of Article V, and the third paragraph. 决定作相应修正。

This decision is in effect as of the date of publication.

The Measures for the Prevention and Control of disposable plastic products in Haikou City are amended accordingly in accordance with this Decision.

Article 1 To protect and improve the living and ecological environment and prevent the pollution of 位和个人应当在产品上标注经省环境保护行政主管 disposable plastic products, the method is formulated in accordance with the provisions of relevant laws and regulations of the State. combined with the actual city of the city.

Article 2 The disposable plastic products referred to in this approach include disposable degradable plastic products and disposable nondegradable plastic products. Disposable nondegradable plastic products refer to disposable plastic catering tools, plastic bags, plastic films and plastic shoes that are difficult to degrade in natural environments, such as polystyrene, polyethylene or polypropylene, which are produced for raw materials.

Article 3 This method shall be implemented by the municipal environmental protection administrative department. The departments of industrial and commercial administration, quality technical supervision, health and sanitation, and other departments are implemented in synergy according to their duties.

Article 4 An alternative to the technical requirements of disposable degradable plastic catering tools and national environmental marker encouraged and supported by enterprises. Article 5 The existing units and individuals for the production of disposable non-degradable plastic catering tools shall be labeled on the products for recycling signs recognized by the provincial environmental protection administrative department, and shall have a recycling responsibility to complete the recycling indicators determined by the municipal environmental protection administrative department.

第十一条 违反本办法的行为,按下列规定处罚:

(一) 违反本办法第五条第一款规定, 未标注回 收标志的,由市环境保护行政主管部门责令限期改 正,并可处以3000元以上10000元以下罚款;未完 成回收指标的,由市环境保护行政主管部门责令限

违反本办法第五条第二款规定, 销售未标注经省 可降解塑料餐饮具的,由工商行政管理部门或质量 技术监督行政管理部门责令限期改正,并处以1000 元以上3000元以下罚款;在经营中使用上述物品 的,由市环境保护行政主管部门予以暂扣,并可处 300元以上3000元以下罚款。

(二) 违反本办法第六条规定, 生产、销售一次 性发泡塑料餐具的,由工商行政管理部门或质量技 术监督行政管理部门依照《海口市禁止生产和销售 假冒伪劣商品条例》的有关规定进行处罚;在经营 中使用一次性发泡塑料餐具的,由市环境保护行政

recycling signs recognized by the provincial environmental protection administration authority in the operation are prohibited.

Article 6 The production, sale and use of disposable sparkling plastic tableware in the operation are prohibited.

and use in operation of disposable nondegradable plastic bags, packaging bags and plastic films with a thickness of less than 0,025 mm 1000元以上3000元以下罚款。 (including 0,025 mm).

The use of disposable non-degradable plastic shoes is prohibited in the eighth hotel and swimming grounds.

Article 9 The disposable plastic products such as plastic packaging bags and plastic catering tools are forbidden in public places.

Public places such as airports, docks, stations, scenic tourist areas (points) and various units in the city, and residents living areas should set up disposable plastic products to collect containers.

11th article The violation of this approach shall be punished according to the following provisions:

(1) In violation of the first paragraph of Article 5 of the present method, the unlabeled recycling mark shall be ordered by the municipal environmental protection administrative department for rectification and shall be punishable by a fine of more than RMB3000 RMB10000 RMB10000; the failure to become a recycling indicator shall be ordered by the municipal environmental protection administrative department for the deadline to correct, and shall be punishable by a fine of up to RMB2000 yuan less than RMB10000 yuan.

In violation of the second paragraph of Article 5 of this method, the sale of disposable nondegradable plastic catering with the recycled logo recognized by the administrative department of environmental protection administration of the province has been ordered by the administrative department of industrial and commercial administration or quality technical supervision administrative department to correct the deadline and a fine of more than RMB1000 RMB3000 RMB3000; the use of the above items in the operation is withheld by the municipal environmental protection administrative department, and is punishable by more than RMB300 by RMB3000The next fine is fine.

(2) In violation of article 6 of the present method, the production and sale of disposable sparkling plastic tableware shall be punished by the administrative department for industry and

第十二条 本办法自发布之日起施行。

commerce or the administrative department of quality technical supervision in accordance with the relevant provisions of the Regulations on the Prohibition of Production and Sale of Counterfeit And Substandard Goods by Haikou City; the use of disposable expanded plastic tableware in operation shall be withheld by the municipal environmental protection administrative department, and shall be punishable by a fine of more than RMB1000 by RMB3000.

- (3) In violation of Article 7 of this method, production, sales thickness under 0,025 mm (0,025 mm) of disposable non-degradable plastic bags, packaging bags and plastic film, withheld by industry and commerce administration or quality technical supervision administrative department, and ordered to correct the deadline; and with illegal gains, punishable by a fine of less than RMB30000 yuan, but not more than RMB30000 yuan; and without illegal gains, it is punishable by 1000A fine of 0 yuan; the use of the above items in the operation is withheld by the environmental protection administrative department, and is punishable by a fine of RMB1000 to RMB3000 yuan.
- (4) In violation of article 8 of the present method, the disposable non-degradable plastic shoe used in the operation is withheld by the municipal environmental protection administrative department, and it is punishable by a fine of RMB1000 to RMB3000 yuan.
- (5) In violation of the provisions of Article 9 of this method, it is ordered by the municipal environmental health administration department to be immediately cleared, and is punishable by a fine of RMB20 to RMB50 yuan.
- (6) In violation of the provisions of Article X of the present method, it shall be ordered by the municipal environmental health administration department to rectify it, and may impose a fine of more than RMB500 RMB2000 yuan under RMB2000 yuan for the responsible unit.

12th article This approach shall be effective as of the date of publication.
