About measures to further improve the system of household waste management

Decision of the President of the Republic of Uzbekistan

The country has a consistent policy in the field of environmental protection, rational use of natural resources, and improvement of the sanitary and environmental situation of the regions.

Particularly, in the short term it is necessary to improve the infrastructure of solid waste management system, to create clusters for complex waste management with total capacity of processing more than one million tons of household waste per year. Extensive work was done. The measures allowed to increase the coverage of the population with sanitary services more than ten times.

At the same time, there are some systemic obstacles to the creation of favorable conditions for the provision of environmental safety, as well as proper sanitation of the settlements, in particular:

Firstly, public-private partnerships in the area of household waste management are insufficient, leading to poor infrastructure and inadequate coverage of residential areas;

Secondly, the situation with the use of secondary material resources, as well as the system of household waste, does not meet modern requirements, which leads to the inefficient use of natural resources;

thirdly, polymer film materials that cause contamination of the settlements are used excessive and distributed, and there is no system for the use of alternative biodegradable materials;

Fourth, an ineffective system for responding to and responding to environmental offenses that result in unlawful acts committed, including non-liability for environmental pollution;

Fifth, there is no modern innovative information and communication technology to assess the actual sanitary and ecological condition of the country.

In order to further develop the system of household waste management, improve the provision of the population with quality sanitation services, as well as to use the existing opportunities to solve environmental problems:

- 1. Decree of the President of the Republic of Uzbekistan dated April 21, 2017 N PP-2916 to the State Committee of the Republic of Uzbekistan for Ecology and Environmental Protection (hereinafter referred to as the State Committee for Ecology) to envisage further expansion of participation in waste collection, transportation, utilization, processing, burial and sale.
- 2. Approve the proposal of the State Ecology Committee to involve business entities on public-private partnerships in the provision of waste collection and disposal services by creating favorable conditions for investment in this area.

3. To establish that from August 1, 2018:

Provision of proper cleanliness of waste collection points on the basis of public-private partnership to district and city territories (hereinafter - territories) to carry out activities on collection and disposal of household waste, as well as independent sorting of household waste attached to the condition;

Assignment of territories to business entities through public-private partnerships to provide domestic waste collection and disposal services is available only on a competitive basis through a single e-commerce platform E-IJRO AUKSION;

Individual waste collection and disposal services are provided by public contracts.

To establish:

In the event that a tender for the provision of waste collection and disposal services to the business entities is not held, the respective territories shall be assigned to the "Clean Zone" or "Mahsustrans" without competition;

The State Committee for Ecology coordinates activities to implement investment projects aimed at attracting investments into the household waste management business.

4. Prosecutor General's Office of the Republic of Uzbekistan and State Committee for Ecology The Council of Ministers of the Republic of Karakalpakstan, regions

and in cooperation with khokimiyats of Tashkent city and other interested ministries and departments within two months:

areas for waste collection and disposal services

development and implementation of an automated information system for collecting materials for business entities and implementing consensus procedures with the competent authorities, as well as integrating it into a single e-commerce platform "E-IJRO AUKSION";

provision of services for the collection and removal of household waste to the business entities by means of electronic auction through the single e-commerce platform "E-IJRO AUKSION".

5. Starting from January 1, 2019, the following will be prohibited:

free delivery of polymer film bundles, including the cost of goods sold in the territory of the Republic of Uzbekistan, as well as their sale at a lower cost (excluding packages that are integral parts and goods);

Production of polymer film packages less than 40 microns in the territory of the Republic of Uzbekistan (packages made of polymer film for export, no handles and integral part of goods, sold for commercial

rolls, as well as bio-filtered polymeric materials except);

Packages of polymer film on the territory of the Republic of Uzbekistan

(TIF TN 3923 21 000 0, 3923 29 100 0, 3923 29 000) packages imported by physical persons for transportation and packing of goods and personal belongings, as well as in transit except for the goods being transported.

The State Committee for Environment Protection, the State Tax Committee of the Republic of Uzbekistan and the State Customs Committee should ensure strict compliance with the requirements specified in this clause.

6. The State Ecology Committee, together with the concerned ministries and departments, will produce and import environmental hazards after the loss of use by January 1, 2020, taking into account foreign experience and comprehensive public discussion. to make proposals to the commodity group on the expediency of introducing environmental fees.

7. By January 1, 2023:

to the Republican Road Fund under the Cabinet of Ministers of the Republic of Uzbekistan for the registration of new domestic vehicles purchased by organizations operating in the field of household waste management. 'levies;

SUE Clean Territory and State Unitary Enterprise "Mahsustrans"

the purposeful deduction of funds from obligatory payments (excluding single social payments) with the purpose of strengthening their material and technical base;

Customs equipment, spare parts and components, raw materials and materials imported on the basis of established lists for use in the technological process of production of biodegradable polymeric materials for packaging and packaging of goods not produced in the Republic donations (except for customs clearance fees);

customs duties on special machinery, technological equipment, spare parts, components imported on the basis of lists approved in the framework of implementation of projects for the establishment of clusters for the implementation of complex waste management services not produced in the country To exempt from customs duties.

8. The National Bank for Foreign Economic Activity and the Central Bank of the Republic of Uzbekistan shall:

within the framework of projects for the establishment of clusters for the implementation of complex household waste management operations, the foreign loans will be replaced by loans (hereinafter referred to as the loans) in national currency and refinancing rate of the Central Bank of the Republic of Uzbekistan. restructuring at a rate not to exceed the rate;

fixing the last repayment period of 7 years from the date of restructuring, with appropriate amendments to the repayment schedule;

Approve proposals of the Central Bank of the Republic of Uzbekistan on the classification of assets in respect of loans issued, not to transfer them to the revised credit accounts and not to create reserves on them .

9. The following are:

Forecast parameters of additional equipment of SUE Clean Territory for 2019-2021 with special machinery and equipment at the expense of the republican budget of the Republic of Karakalpakstan and local budgets in accordance with Annex 1;

Targeted program for the construction and equipping of waste collection points at the expense of the republican budget of the Republic of Karakalpakstan and local budgets in 2019, according to Annex 2;

Approve the target program for equipment of the existing polygons of the "Toz Zone" SUE at the expense of the republican budget of the Republic of Karakalpakstan and the local budgets of the regions in 2020, in accordance with Annex 3.

To authorize the Republican Commission on Coordination and Improvement of Waste Management System to make adjustments to the forecast parameters and targeted programs provided in this paragraph.

- 10. The State Committee for Ecology of the Republic of Uzbekistan:
- a) The Ministry of Economy, together with the Ministry of Finance before July 1, 2018:

Draft Regulation on the Procedure for Assigning Zones to Entrepreneurs to Provide Household Waste Collection and Disposal Services;

submit to the Cabinet of Ministers a draft standard public service agreement for the collection and disposal of domestic waste to individuals;

b) in conjunction with the Ministry of Internal Affairs of the Republic of Uzbekistan till August 1, 2018:

developing effective mechanisms to hold individuals accountable for pollution, to increase the responsibility of citizens and officials in the field of waste management;

installation of containers (trash bins) in public places, including their standard forms, as well as installation of these containers (trash bins) near or adjacent to buildings belonging to the organizations themselves to submit proposals with the following requirements:

c) in cooperation with the Ministry of Development of Information Technologies and Communications of the Republic of Uzbekistan till September 1, 2018:

Creation of a special web portal that allows the public to control the state of the environment, to post photos and video materials about violations in this area, and to take immediate action in every reported case implementation of the system;

The official website of the State Committee for Ecology provides an electronic map of all waste collection points, including the number of settlements, residential communities and existing containers across the country for public-private partnerships and public oversight in the area. Provide page.

- 11. The Council of Ministers of the Republic of Karakalpakstan, governors of regions, cities and districts have special vehicles owned by organizations operating in the area of household waste management (agricultural, non-agricultural). construction, etc.).
- 12. The State Ecological Committee of the Republic of Uzbekistan jointly with the interested ministries and departments within two months to submit to the Cabinet of Ministers proposals on amendments and additions to the legislation arising from this decision.
- 13. Control of execution of this resolution to assign to the Prime Minister of the Republic of Uzbekistan ANAripov, the first deputy of the State adviser of the President of the Republic of Uzbekistan BMMavlonov and the chairman of the State committee of the Republic of Uzbekistan on ecology and environment BTKuchkarov.
